Employed (full time job) in NOOIS - Executive Director of the National Organization of Persons with Disabilities of Serbia (NOOIS) from its foundation (2007), representing over 800,000 PWDs, and also working on inclusion of PWDs in the society. Key duties: advocacy for human rights, cooperation with different stakeholders – state institutions, DPOs and CSO and international organizations, organization development, program and project management, international cooperation.

Background of main activities in the field of the rights of persons with disabilities:

- Working engagement from 1993 in Muscular Dystrophy Association of Serbia – still engaged there as an expert associate
- Close cooperation with Handicap International and coordinator of Counseling center for psycho-social support to PWDs
- Currently very active in the Serbian disability movement as Executive Director of NOOIS with excellent knowledge of disability policy and human rights advocacy for PWDs
- Long term international experience and close cooperation with different international organizations – UN Mission in Serbia, UNICEF Serbia, OSCE Mission in Serbia, ILO Serbia, USAID, European Economic and Social Committee etc.

Relevant expertise on the rights of persons with disabilities and expertise under the Convention on the Rights of Persons with Disabilities (relevant to the mandate of the treaty body concerned):

- Monitoring the UN Convention implementation and working on harmonizing Serbian regulations and practices
- Active participation in various activities related to the harmonization of Serbian regulations in the areas: abolishing guardianship and introduction of decision-making with support, in the field of deinstitutionalization; work and employment; in fields of systematic introduction of prohibition of disability-based discrimination in new legislation; in the process of amendments to Criminal Code criminalizing disability - based discrimination and increasing penalties for acts of sexual violence against persons with disabilities; in the process of recent ratification of the Marrakesh Treaty
- Very active role (as a part of the working group) in the process of writing the new National Disability Strategy of Serbia for the period 2020/2024, especially through systematic incorporation of recommendations from Committee's Concluding Observations to Serbia into the new National Disability Strategy

- Many years of dealing with issues in the field of improving the position of persons with disabilities
- Excellent knowledge of the concept of human rights and policies in the field of human rights of persons with disabilities (at national and international level)

- Good knowledge of domestic and international regulations, especially the UN Convention
